



FLEET CAR WASH AGREEMENT

How it Works

In order to qualify for this program, your company must spend a minimum of \$35 per month in car washes for the Fleet discounts to apply.

\$9 - Basic Wash.....	5% discount.....	\$8.55
\$14 - Deluxe Wash.....	10% discount.....	\$12.60
\$18 - The Works Wash.....	20% discount.....	\$14.40

Once you are a member of our Fleet Program, you have the option of using Fleet Cards or Fleet Tags.

Fleet Cards look like a credit card and can be shared amongst your employees for use on multiple vehicles. Fleet Cards are ideal if you have one person that takes care of vehicle maintenance for multiple vehicles. Each time your staff pulls up to our pay station they will swipe this card and the gate arm will automatically open allowing the driver to enter the car wash.

Fleet Tags are RFID Tags (Radio Frequency Identification) that will be attached to each vehicle’s windshield behind the mirror (small bar code sticker). Each time one of your fleet vehicles pulls up to our pay station, an electronic eye will read the RFID tag and the gate arm will automatically open allowing the driver to enter the car wash without even rolling down their window.

The credit card on file will be automatically charged on the last day of each month for that months’ washes. On the first of the month your company will be emailed a usage report showing date, time & wash selected. You may limit the number of washes that the vehicles can receive and can cancel at any time.

Terms and Conditions

1. Registered vehicle(s) using the Fleet Tag option must have a White Water Express RFID (Radio Frequency Identification) sticker tag affixed to windshield behind the mirror. A damaged RFID tag must be reported to White Water Express Car Wash, LLC immediately. Any attempt to remove the tag will destroy it and will keep it from operating. Member will be charged for the tag replacement.
2. If the Fleet card is lost or destroyed the member will be charged for the replacement.
3. Member must notify White Water Express Car Wash, LLC of any change in vehicle ownership immediately.
4. Valid credit card required to participate in program.
5. Member agrees that the credit card they provide will be automatically charged on a pay per use basis on the last day of each month. On the first of the month your company will be emailed a usage report showing date, time & wash selected.
6. In the event that the customer wishes to cancel program, cancellation must be received by a member of our management team in writing.
7. If participation is canceled, the credit card on file will be automatically charged for any outstanding washes.
8. It is the customer's full and sole responsibility to contact White Water Express Car Wash to give notification about any changes of contact or billing information. Contact our management team at 970-524-9274 or email: info@whitewaterexpresscarwash.com.
9. Please provide at least seven (7) working days before your billing date for cancellation of program to take effect.
10. In the event that White Water Express Car Wash is unable to charge a customer's credit /debit card due to an expiration date on the credit/debit or other change in information, then the customer's participation in the program will be suspended and his/her pass de-activated five (5) days after recharge date.
11. Vehicles must conform to White Water Express Car Wash standards. Modifications outside of White Water Express Car Wash standards to existing customer's vehicle may require program termination. Please see location manager for confirmation that vehicle meets standards.
12. Stickers and cards remain the exclusive property of White Water Express Car Wash and must be surrendered upon request. In the event that windshield sticker is tampered with or the program is used in any way inconsistent with its terms and condition, the program will be immediately voided and all monies will be forfeited. Failure to return any and all stickers and cards at the termination of this program will result in a charge to the Member's credit card for the replacement cost of such stickers or cards.
13. Pricing and Terms & Conditions are subject to change at any time without notice.
14. White Water Express Car Wash reserves the right to terminate any fleet wash program at any time without notice.
15. No refunds for days that we close early or do not open due to weather or equipment maintenance
16. The Fleet Car Wash Program cannot be used in conjunction with any other discounts.
